

Pack 837 Guidelines for Participation

1. I understand that much of the work for the Bobcat, Tiger, Wolf, and Bear badges must be performed at home, often with my assistance or encouragement.
3. If I find it difficult for my son to attend Den and Pack meetings on a regular basis, I will not simply let my son drop out. Instead, I will take the initiative to discuss the situation with my son's Den Leader or the Cub master so that we may attempt to make adjustments that will enable my son to have regular attendance.
4. I will help my son keep track of his progress towards each badge / rank and help him to understand what remains to be completed in order for him to earn his next badge / rank.
5. I understand that the Pack is a family orientated organization run by the parents and other volunteers interested in providing a fulfilling and fun program for my son. I understand that without parent involvement in the planning and execution of the program there is no program. I agree to assist the Pack Leaders to the best of my ability when called upon at Den and Pack Meetings.
6. I understand that the Pack annual dues and fees to Boy Scouts of America are primarily funded by our annual Popcorn Sale. I agree to assist my son to generate \$84 in **profit** for the pack. **A goal of \$84 profit is based on a scout sales goal of \$300 with a pack commission rate of 28%.** The remaining 75% goes to the district scout facilities. If he is unable to sell a minimum of \$84 profit, then I agree that to fund the difference to the pack.
7. I understand that as a representative of Boy Scouts of America, we want to represent this organization in a respectful and positive manner by properly wearing and displaying the uniform at all times. The required uniform is the shirt, belt, neckerchief, and neckerchief buckle.
7. I understand that Cub Camp Day Camp is funded primarily by our annual Camp Card sales. A scout needs to sell 34 camp cards thru individual and/or group sales to fund their way to Cub Camp. If a scout sells 34 camp cards, the scout will earn \$85 toward his Cub Camp fees of \$85. This includes the \$75 camp fee and an additional \$10 for the cub camp hat. Each card is valued at \$5 and the pack commission rate on each card sales is 50%. If he is unable to sell a minimum of \$85 profit, then I agree that to fund the difference to the pack if your scout plans to participate in cub camp.
8. I understand that annual dues that cover fees and expenses related to activities and curriculum primarily fund activities of the Pack. Annual dues are \$80 if paid in full by the 1st pack meeting in October. If you elect to pay these monthly, the due are \$10 a month, which is \$90 for 9 months of scouting activities. Rank badges and other recognition awards will not be given to your scout unless your due status is in good standing with the Pack.
9. Financial assistance is available for those families unable to pay the annual dues or purchase the required uniform. I will contact the Cub Master or Den Leader directly to remain in scouting. The Cub Master or Den Leader will bring this matter to the Pack Committee for approval.
